Based on the volumes reported to us, we can confirm that the manufacturer/formulator's imports to the EU are, and have been, REACH-compliant up to the present date. The above REACH registrations may cover both direct and indirect imports to the EU/EEA. The full registration numbers above, are available upon request.

**To maintain compliance under the regulation's requirements for complete and accurate record-keeping, indirect imports tonnages must be reported to Reach Only Representative (Ireland) Ltd.** This reporting may be done either by the non-EU/EEA exporter (e.g. distributor) or the EU/EEA importer receiving the products. This must be done at a minimum, per calendar year. Although ideally, records should be provided: every three to six months, per calendar year.

Reach Only Representative (Ireland) Ltd., accepts the responsibility for the purposes of import under REACH as the Only Representative for the listed components in the products which have been registered, or which may remain below the registration threshold. For indirect imports: this is only where the relevant tonnages have been reported to us by the non-EU/EEA exporter (e.g. distributor) or the EU/EEA importer.
